The Albion Monitor - a subscription service with free archives

The ALBION MONITOR is a paid subscription service which focuses on the impact environmental and political issues have on people. A free sample issue is accessible at the web site. Albion Monitor aims to cover "non mainstream" topics and has some international coverage.

GreenBeat!

The Texas Environmental Center produces GreenBeat! with funding from AT&T. This monthly Internet magazine features students' efforts in environmental protection and communication. It offers articles on environmental issues, links to Internet resources, and announcements of career opportunities. The March 1996 issue, entitled "Pathways to Involvement" offers the following sections: "College Choices," "Community Volunteering," and "Environmental Jobs."

Initiatives in Environmental Technology Investment

Published six times a year by the Urban Energy and Transportation Corporation (UETC), Initiatives is designed to aid communication and interaction between and within the Department of Energy's Office of Technology Development and industries and other agencies concerned with technology development and exchange.

A weekly electronic newsletter with reviews of environmental, agricultural, and natural resources World Wide Web sites. Organizations', government agencies', or political sites are reviewed. The web site is the source for an archive of an HTML-version of the newsletter, a calendar of global environmental conferences, and an index of USEPA Federal Register Daily Table of Contents.

Journal of Environmental Planning and Management

The central aim of the Journal is to focus on the integrated planning and management of the environment from an interdisciplinary and international point of view. Types of papers published include applied research, the application of new approaches and techniques, and the evaluation of policy and practice. The editors consider also short reports, speculations, and commentaries on any aspect of environmental planning and management; they especially welcome contributions from integrated and cross-disciplinary research teams and from policy makers and practitioners. Subscription rates are \$112 for personal and \$398 for institutional subscription in North America.

Three publications aimed at corporations from Cutter Information

1. Business and the Environment (BATE)

BATE is a monthly newsletter designed to provide a strategic look at environmental issues for managers. Kate Victory, BATE editor, features international news about trends in environmental regulations, case studies and specific examples of corporate environmental initiatives, and techniques companies have used to avoid costly mistakes. This newsletter is aimed at corporate subscribers; subscription price is \$397/year in North America.

2. Environment Watch: Western Europe

A newsletter published twice monthly, Environment Watch: Western Europe joins related publications BATE (see above) and Environment Watch: Latin America and is intended to help readers stay up-to-date in their knowledge of environmental regulations and legislation in all of Western Europe. New requirements are being developed for areas such as environmental liability, packaging, ecolabeling, water quality, waste management, and vehicle emissions. The newsletter costs \$797/year in North America.

3. Global Environmental Change Report

Global Environmental Change Report is a twice-monthly newsletter covering policy, science, & industry news in the area of global environmental change. Each issue contains an in-depth focus report on topics like ozone depletion, global warming, and acid rain. Subscribers receive also quarterly lists of documents and announcements of international meetings. Subscription cost is \$457/year in North America.

Plain English Guide to the Clean Air Act

This guide explains the Clean Air Act of 1990, the most recent version of the 1970 legislation which made major changes to the Act. In straightforward language, the guide summarizes important provisions of the 1990 Act, describes reasons to be concerned about air pollution, lists common air pollutants and their sources, and provides a glossary. Basic explanations of acid rain and the ozone layer are provided, and one section of the guide discusses how to tell the Clean Air Act is working. Although the EPA document is dated 1993, revisions have been made in January of 1996.

Community Environmental Council (CEC) Sustainability Publications

The Community Environmental Council (CEC) was founded in 1970 in Santa Barbara, California and is "dedicated to addressing the practical challenges of putting appropriate conservation measures into practice." CEC is an internationally recognized nonprofit research, policy development, and education organization which works to connect government agencies, business and industry, universities, regulatory bodies, environmental organizations, and the community in an effort to solve environmental problems through design and implementation of innovative environmental management systems. CEC's publications are available free of charge, now accessible through the Internet. Some sample titles are: BUILDING THE SUSTAINABLE CITY, SUSTAINABLE COMMUNITY INDICATORS: GUIDEPOSTS FOR LOCAL PLANNING, MANUFACTURING WITH RECYCLABLES: REMOVING THE BARRIERS, and RECYCLING MARKET DEVELOPMENT: A QUESTION OF RESPONSIBILITY

Global Thinking Project

The Global Thinking Project (GTP) is an effort to develop collaboration among teachers and students (ages 10 - 17) from around the world in studying their local environments and participating in global discussions of environmental issues. GTP schools work with each other within Global Communities which consist of six to eight schools using the Internet as communication mechanism. Participating schools follow an annual GTP curriculum which is a series of projects students carry out on topics such as weather, climate change, pollution, and waste management. The GTP offers teachers leadership training and supports research activities

among graduate students in science education and professors and teachers involved in GTP activities.

National Library for the Environment

The National Library for the Environment is a project of the Committee for the National Institute for the Environment (CNIE). The library addresses the need for objective, scientifically sound information on environmental issues. It will eventually include three on-line components: Congressional Research Service Reports; An Encyclopedia of the Environment; and In Depth Issues in the Environment.

Interstate Renewable Energy Council (IREC)

IREC works to accelerate the sustainable use of renewable energy sources and technologies in and through state and local government activities. IREC's web site includes program information, publications, and membership information. A section called INDEX (http://www.eren.doe.gov/irec/docs/pv4u_ndx.html) is published twice a year and lists recent application, policy, financial, and program documents in 15 categories including Environmental Issues, Green/Friendly Pricing, State Action, Directories, Catalogues & Bibliographies, Newsletters, Magazines & Books, and Information & Organization Resources.

Geological Indicators of Rapid Environmental Change: An International Checklist

Geoinicators are twenty-seven earth system processes and phenomena which are liable to change in less than a century. The indicators checklist was developed by the Geoinicators Working Group of the International Union of Geological Sciences' Commission on Geological Sciences for Environmental Planning. Geoinicators concentrate on non-living processes such as the dune formation and reactivation, groundwater quality and chemistry, soil and sediment erosion, and their interactions with the atmosphere and biosphere. They serve as tools to assist in integrated assessment of natural environments and ecosystems.

National Biological Information Infrastructure (NBII) and Global Change Master Directory

The NBS and NASA have agreed to cooperate in supporting development of biological and ecological databases by contributing their data to two electronic sites available on the Internet. The NBII will provide

information on and access to biological databases, information products, directories, and guides maintained by federal, state, and local government agencies, and private organizations. The Global Change Master Directory (GCMD) is a comprehensive source of information about earth science, environmental, biosphere, climate, and global change data holdings available to the scientific community throughout the world. The GCMD is the American Coordinating Node of the Committee on Earth Observation Satellites International Directory Network (CEOS IDN) and is a component of the Global Change Data and Information System (GCDIS).

WebActive

An up-to-date online publication designed to connect socially conscious citizens and activists with organizations which are responsive to their concerns. Released in January 1996, WebActive is visited by nearly ten thousand people each week. WebActive features a site each week and offers a directory which is searchable by topic in order to demonstrate relationships among issues.

World Wide Fund For Nature (WWF)

The WWF is launching its web site, the WWF Global Network. The site presents new information about all aspects of conservation and the environment, including topics such as: forests, climate change, marine issues, pollution, species, and sustainable development. Links to Internet sites, mailing lists, and newsgroups are provided. Sections called "Publications and Research" and "Experts' Database" lead to current research groups and keyword searchable biographical information on environmental educators, researchers, and scientists.

Eco Travels in Latin America

Eco Travels in Latin America is developed by Ron Mader, freelance environmental business writer who specializes in Latin American issues. The site offers a wide variety of information resources on environmentally conscious travel. Details on eco-travel destinations are accessible by geographic region, and background information is supplied on environmental threats to the regions. The site provides links to archives of "El Planeta Platica," a newsletter published since 1994 covering Latin America, the environment, and travel. Eco Travels presents a compilation of "resources" for green travelers that includes lists of publishers, travel companies, tourism offices, contacts, Spanish language schools, tapes, recipes, and book reviews. Links to other

environmental, Latin American, Latino, and eco tourism sites are maintained.

EPA Regional Homepages - [Region 1](#) & [Region 6](#)

Region 1 includes: Maine, New Hampshire, Vermont, Massachusetts, Connecticut, and Rhode Island; Region 6 covers Arkansas, Louisiana, New Mexico, Oklahoma, and Texas. The Region 1 homepage currently offers access to information on programs and special initiatives underway in the New England area, and is planning to present more information, such as data sets and software tools, in the future. The Region 6 homepage presently focuses on their Water Quality Protection Division and regional geographic information systems, and provides links to other servers that maintain information relating to Native Americans and the various states in the region.

EPA's New Era of Voluntary Partnerships Programs

Partners for the Environment programs represent cooperative partnerships among businesses, other stockholders, and the EPA. This webpage currently provides information on programs in the following categories: toxics reduction, reporting and efficiency; agriculture; global climate change; energy efficiency and conservation; state and local; solid waste; and compliance.

Environmental Contaminants Program of the U.S. Fish and Wildlife Service

The program "directs efforts to identify and assess contaminant effects on fish and wildlife in order to prevent, reduce, and/or eliminate contamination problems." Some sections of the website include: Contaminant Identification and Assessment; Natural Resource Damage Assessment and Restoration; and Directory of Personnel.

EPA Government Information Locator Services

"Government Information Locator Service (GILS) is a new electronic service intended to provide a decentralized location for access to government information. GILS has an extensive listing of the Agency's information resources; describes the information in those resources; and provides the necessary assistance in obtaining that information."

EPA's Microbiology Home Page

EPA Microbiology website has replaced the EPA Microbiology Gopher which was operational from January 1994 through November 1995. The site offers the full-text of several publications, such as the USEPA Manual of Methods for Virology. In addition, a year-by-year listing (1990-1994) of publications provides full bibliographic information for documents resulting from EPA-sponsored research in microbiology. An interesting feature of this site is an image gallery of microorganisms.

[Superfund Home Page Office of Emergency and Remedial Response](#)

This website provides a brief overview of the objective of the Superfund program and, most notably, a listing of both current and previous Superfund sites. The data for these site lists have been culled from the Comprehensive Environmental Response, Compensation and Liability Information System (CERCLIS) and the Records of Decision System (RODS), include "general" and "event" information, and are organized alphabetically by state and then city or town. For CERCLIS and RODS data in other media, such as diskette, CD-ROM, print, or through the Freedom of Information Act (FOIA) process, information on who to contact and phone numbers are provided.

This institute promotes "green plans" as a strategy for achieving sustainable development in land use and transportation planning. The web site includes an online version of Green Planner, the organization's newsletter; and A Green Plan Primer, which provides background information on green planning, business and the environment, and sustainable development.
